III. Jeanne Scott, Sunny Hills

Jeanne is Director of Programs at Sunny Hills. She has been with Sunny Hills for 17 years. Many programs which include:

- 1. TBS- Therapeutic Behavioral Services: outpatient, intensive car, medical, home-based, ages from very young through high school.
- 2. Hunt School: Identified needs that aren't being met in traditional school methods. San Anselmo campus, K-12 grade, 40 students maximum.
- 3. Guardian Scholars- AB-12, currently under review by Sunny Hills to see whether to continue. Have had 8 youth in past, now have 1. Children must be committed to school (community college) to be eligible. How can this program be more effective? Jeanne is meeting with the CPO and CEO to discuss all options. The program has 2 buildings that can hold 10 kids each, but not enough staff for 20 residents.

Marilyn suggested that California Youth Connection would be a good referral source. Dana suggested connecting with Claudia Asprer, Girls on the Move. She works with post-foster care transitional age youth and has many referrals.
