- I. Call to Order, Introductions, Presentation

  - A. Review and approval of October 2019 Meeting Minutes
  - B. Presentation - Marin Prevention Network - Jazzy Gerraty  
The Marin Prevention Network seeks to change community norms, policies, and laws that affect the availability, promotion, sale, and use of alcohol and other drugs to create a community environment that promotes healthy choices and reduces risk. Jazzy spoke in detail about the Marin Youth Partnerships, and the ideal 12 sectors involved in decision-making. Initiatives include: Raising the Bar, Be the Influence, Community Concern Booklets, Community Forums and events, such as town halls, community book reads, and partnering with Wellness Centers.

- III. Updates, Reports, Follow-ups

#### A. Juvenile Hall Update

Tori reported. Snapshot of JH occupancy was shared. A lot of activity in in October with most kids in for VOP and consideration of one minor being sent to Youth Authority. Mental Health issues are an ongoing concern. Good news- during power outages, JH kept up with programming. Tori also reported that they are looking into getting a different drug and alcohol education program in JH.

#### B. Youth Court Update Youth Court

Don reported. Given the inherited SR case load (YC is now addressing some 150 cases) and the percentage of Latino youth increasing, there is a need for Spanish speakers. In addition, YC is working in San Rafael schools on alternatives to suspension, including framing 6-week restorative circles led by former participants to divert suspension and criminal prosecution.

#### C. MCOE

Ken Lippi, Marin Office of Education, updated us on MCOE's current activities, including moving technology into the JH classroom and upgrading texts and the library. Classes are on an uptick, with IEPs, as well as educational assessments in place. Ken reported that Marin's Community School (MCS) which has been redesigned and retooled is now accredited, has great school spirit and students who want to stay at MCS and graduate.
