 - a. Recommend that SRO change their uniform while on school campus to not intimidate the students

A. Juvenile Hall Updates

- 1. Three males in juvenile hall, and another one was released in the morning in juvenile hall for violating probation (numerous graduated sanctions), leaving court ordered placement, or because of severe mental health issues
- 2. All juveniles have now been vaccinated
- 3. Probation and courts are continuing to try to keep juveniles out of the juvenile hall during the pandemic
- 4. Yoga has returned, gardening continues, and visitation is happening via Zoom
- 5. Marin County has five beds for wards of the court but foster parents can refuse kids
 - a. Juvenile can no longer be sent to out of state placement
 - b. The placement a juvenile is referred to depends on the risk the juvenile possess to himself and others
 - c. Juveniles on probation can't live with foster children in a placement like setting
