Purpose Statement

The Marin County Juvenile Justice and Delinquency Prevention Commission serves as a state mandated, court-appointed authority that inquiries into the administration of the juvenile justice system of Marin County. Key functions of the Commission, as specified in the by-laws, include: the annual inspection of any juvenile confinement facility, coordinating and conducting public or closed hearings on matters relevant to Juvenile Justice, and assuring that needed services are identified, developed, and provided for all children and youth of the County, particularly services related to the diversion of youth out of the Juvenile Justice System.

Overarching Principles (Guiding or Governing Principles)

- Reduce Disproportionate Minority Confinement (DMC) for youth in Marin.
- Increase Marin's community education and awareness of the principles and practices of Restorative Justice.
- Support the widespread use of Evidence Based Practices (EBPs) and discourage use of non-evidenced based practices for youth.
- Engage stakeholders in ongoing needs assessment to continually inform countywide Juvenile Services and Justice practices.

Overarching Goals

- Advocate a shift towards an inclusive community that cherishes all youth in Marin regardless of circumstance, context, documentation, etc. and away from "us" vs. "them
- Advocate a shift towards restorative practices and away from punitive practices.
- Decriminalize substance abuse and support proactive treatment for all youth confronting substance abuse issues.
- Strengthen partnerships between the MCJJDPC and the Courts, the Probation Department, Law Enforcement, the Board of Supervisors, H&HS, local government, MCOE & local school administration, the nonprofit sector, and the community at large.

Short Term Programmatic Goals

#1: Raise awareness within Marin of Restorative Justice and support the creation of sustainable community-driven restorative practices throughout the County.
